Quotations should be sent under the sealed cover marked as: "Quotation for the supply Air Conditioner" and not by name. The quotation received from the agency / dealers / suppliers must have GST.

2. Quotations shall be submitted as per the requirement specified in "Annexure-A" in accordance with the terms and conditions specified in paragraphs 3 to 9. Unless otherwise specified in the quotations, it shall be construed that the terms and conditions stipulated hereunder have been agreed to. All products must be from a branded company.

The undersigned does not bind them to accept the lowest quotation and reserves the right to accept the quotation in whole or in part i.e., with respect to all the materials / articles mentioned in the attached statement or in respect of one or more than one articles specified in the attached statement as she may decide.
6. On acceptance of the quotation it will become a contract and the contractor shall be bound by the terms and conditions of the quotation.
7. If the contractor fails to supply the articles within the time stipulated in the letter of acceptance / purchase order by the undersigned, the undersigned shall be at liberty to purchase the articles from the market or get the rest of the contract completed by any other person or firm.
8. Prior to acceptance of the quotation, the undersigned reserves the right to call for samples or demonstration and the contractor shall be liable to supply the samples or give the demonstration free of cost.
