All products must be from a branded company and superior quality of Fiber Reinforced Plastic & Iron.

- **3.** The rates should be F.O.R. and should include excise duty, sales tax, GST, freight charges, any other taxes, rates or impositions which are leviable e.g., packing charges in respect of the supplies. The undersigned does not bind them to accept the lowest quotation and reserves the right to accept the quotation in whole or in part i.e., with respect to all the materials / articles mentioned in the attached statement or in respect of one or more than one articles specified in the attached statement as she may decide.
- 6. On acceptance of the quotation it will become a contract and the contractor shall be bound by the terms and conditions of the quotation.
- 7. If the contractor fails to supply the articles within the time stipulated in the letter of acceptance / purchase order by the undersigned, the undersigned shall be at liberty to purchase the articles from the market or get the rest of the contract completed by any other person or firm.
