1. Sealed quotations for the supply of the materials shown above are invited by the undersigned on behalf of DAV Public School, Berhampur upto 11:00 A.M. by 31st May 2024.
Quotations should be sent under the sealed cover marked as: "Quotation for the supply of printing and supply of the syllabus" and not by name. The quotations will be opened in the office of the undersigned at 10:30 A.M. on 3rd June 2024.
2. Quotations shall be submitted in Annexure A and in accordance with the terms and conditions specified in paragraphs 3 to 9. Unless otherwise specified in the quotations, it shall be construed that the terms and conditions stipulated hereunder have been agreed to.
3. The rates should be F.O.R. and should include excise duty, sales tax, freight charges, any other taxes, rates or impositions which are leviable e.g., packing charges in respect of the supplies. The school shall not be liable to pay any tax, freight, etc. which has not been expressly stipulated in the quotation in the event of acceptance of the quotation.
4. There should not be any overwriting or corrections in the quotation. If a figure is to be amended, it should be neatly scored out, the revised figure written above and the same attested with full signature and date. In the absence of such attestation the quotation is liable to be rejected.
5. The undersigned does not bind herself to accept the lowest quotation and reserves the right to accept the quotation in whole or in part i.e., with respect to all the articles mentioned in the attached statement or in respect of one or more than one articles specified in the attached statement as she may decide.
6. On acceptance of the quotation it will become a contract and the contractor shall be bound by the terms and conditions of the quotation.
7. The quantity of articles indicated in the attached statement may be increased or decreased at the discretion of the undersigned without assigning any reason.
8. Prior to acceptance of the quotation, the undersigned reserves the right to call for samples or demonstration and the contractor shall be liable to supply the samples or give the demonstration free of cost.
9. Quotations which do not comply with the above conditions are liable to be rejected.
